Sh. On this tenth day of January 1822 personally appeared in open court (being a Court of Common Pleas in and for said County, and constituted a court of record by proceeding according to the course of the common law, with a jurisdiction unlimited in point of amount, and keeping a record of its proceedings, and recognised as such court by the laws and judicial decisions of said State.) Thomas Hill aged sixty years resident in the town of Alga in said county, who being first duly sworn according to law doth on his oath declare, that he served in the revolutionary war as follows: - that in May 1777 he entered the army in Colonel Mylles regiment of Connecticut troops, in which he continued, in Captain Bliff company, three years and performed the service more particularly set forth in the declaration accompanying his original application for a pension - that during this time and while serving in Colonel Meigs regiment of detached infantry, at the storming of Stoney point, he was severely injured from which he now suffers considerably - and that he made application for a pension on the fifth day of May 1818, and that he received a pension certificate, dated January 3. 1819, but not received.

And I do solemnly swear that I was a resident citizen of the United States on the eighteenth day of March 1818 and that I have not since that time by gift, sale or in any manner disposed of any

property or any part thereof with intent thereby to diminish it as to bring myself within the provisions of an Act of Congress entitled "An act to provide for certain persons engaged in the land and naval service of the United States in the Revolutionary war" passed on the eighteenth day of March 1818. and that I have not nor has any person in trust for me any property or securities, contracts or debts due to me nor have I any income other than what is contained in the schedule hereto annexed and by me subscribed viz:-

Queens County ss: On this fifth day of May in the year of our Lord 1818 before me the subscriber one of the Judges of the Court of common Pleas of the County of Queens in the State of New York, personally appears Thomas Hill aged fifty five years resident in the County of Queens and State aforesaid, who being by me first duly sworn according to law doth on his oath make the following in order to obtain the provision made by the late act of Congress, entitled an act to provide for certain persons engaged in the land and naval service of the United States in the Revolutionary war

That the said Thomas Hill enlisted in the month of May in the year 1777 in the town of Pomperun in the State of Connecticut in a company commanded by Capt. Slett in a Regiment commanded by Colonel Willis in the Connecticut line

That he continued to serve in the said corps ^{in the service of the United States} until April or May in the year 1780 when he was discharged from service at Westfield or Springfield in the State of New Jersey - that he was in the battle at the capturing of Stony Point - and that he is in reduced circumstances and stands in need of assistance from his country for support, and that he has no other evidence now in his power of his said service

Madam;

I have to advise you that from the papers in the Revolutionary War pension claim, S. 43678, it appears that Thomas Hill enlisted at Pomfret, Conn., May 1777 and served as a private three years in Captain Clift's company, Colonel's Kelly's and Meigs' Conn. regiment. He was wounded in the battle of Stony Point, no details of said injury, on record.

He was allowed pension on his application executed May 5, 1818, while a resident of Genesee Co., N. Y., aged 56 years.

In 1823, soldier was living in Riga, Monroe Co., N. Y. and stated that his wife, Mary, was 59 years old.

There is no further family data on file.
